1. To announce the commencement of the Annual General Meeting 2016.

The commencement of the Annual General Meeting 2016 was announced by the Vice Hon. Secretary, Mr. Ho Wing Yin as the quorum had been met.

To receive and confirm the minutes of the last Annual General Meeting held on 31st 2. July 2015.
