Membership Requirement for Fellow

Membership is available, irrespective of sex and nationality but according to qualifications and experiences, to persons engaged in the practice of medical laboratory sciences and in good conduct and willing to observe the statute of the Institute.

Fellow (Corporate Membership)

Person who has been an Associate of the Institute for not less than 2 years, at present registered as Part I Medical Laboratory Technologist and has acquired at least one of the following:

- Having presented thesis, under the recommendation of two current Fellows and approved by the Executive Council.
- Having made distinctive contribution to the Profession, under the recommendation of two current Fellows and approved by the Executive Council.
- Having passed the Fellowship Examination held by the Institute.

Annual Subscription: HK\$180

- Membership dues are paid annually, and cover the calendar year, from April 1 to March 31.
- Application approved after 1st January of each year, the annual subscription for that year will be exempted.

Benefits and Obligations

- Fellows have the rights of election, proposal and vote, and are entitled the welfare stipulated in the objectives.
- Current Fellows are entitled to use FHKIMLS as their designations.
- Person who stops serving in the field of medical laboratory sciences can reserve his/her membership. He/she should keep on paying the annual subscription, but he/she should not take the position of office-bearer in Executive Council (EC).
- Members should obligate the decisions approved in the Annual General Meeting (AGM) or the Extra-Ordinary General Meeting (EGM).
- Members should pay annual subscription according to the regulation.

Disciplines and Penalties

- If member has offended against the following conditions, subject to the approval of EC, he/she will receive warning or expulsion from the Institute.
 - Violate the constitution or do not obey the decision of AGM or EGM.
 - Damage the honorary of Institute.
 - Use the name of Institute without authorization.
 - Delay payment of annual subscription over 6 months (suspended from the entitlement of benefits stated in the constitution).
 - Violate the Supplementary Medical Professions (SMP) Ordinance.
 - Offend against criminal laws and has been declared guilty.
- If member is warned or dismissed from the membership, he/she can appeal in the AGM or EGM which then makes the final decision.
- If the expulsion is due to delay payment of annual subscription, he/she can apply for reactivation of their membership by paying the outstanding amount.

Instruction for Application

The applicant should send the completed Upgrade Form and photocopies, together with a crossed cheque made payable to "Hong Kong Institute of Medical Laboratory Sciences Ltd." covering annual subscription of appropriate membership status or the difference if annual subscription for the year has been paid, to the Registrar of the Institute, through the address as in the Form.
